SB# = Studbook number, sequential by hatch date. **114M/none** means Male #114, no tag. **LAZ** = Los Angeles Zoo. **SDWAP** = San Diego Wild Animal Park (now San Diego Zoo Safari Park). **WCBP** = Peregrine Fund's World Center for Birds of Prey in Boise, Idaho. **Portland** = Oregon Zoo in Portland, OR. **VC** = Vermilion Cliffs. **Hurricane** = Hurricane Cliffs, a briefly-used 2nd release site north of the western part of Grand Canyon. **"Captured for behavior"** in AZ has generally meant approaching people, but for some birds originally released in CA the issue was landing on power poles. **AC-9** (father of 122M/22, grandfather of **350M/-0** and **342M/42**) was the last wild condor caught Easter Sunday 1987, released back into the wild in CA on May 1, 2002.
